OFFICIAL RULES

The I Love Yarn Day Scavenger Hunt (the “Hunt”), sponsored by Craft Yarn Council (or “Sponsor”), begins on September 15, 2016 at 12:01 a.m. Eastern Time (“ET”) and ends on October 23, 2016 at 11:59 p.m. NO PURCHASE NECESSARY TO ENTER OR WIN. NO ENTRY FEE. VOID WHERE PROHIBITED. THE HUNT IS LIMITED TO THE 50 UNITED STATES AND THE DISTRICT OF COLUMBIA ONLY. ENTRY IN THIS HUNT CONSTITUTES YOUR ACCEPTANCE OF THESE OFFICIAL RULES AND THE TERMS OF THE HUNT.

1. THE HUNT: Participants must answer 21 questions correctly and enter their answers at the Sponsor’s website. Only ONE entry per person. On or before November 1, 2016, Sponsor will randomly select and announce winners of the Hunt and award prizes in accordance with these Rules.

2. ELIGIBILITY: The HUNT is open to legal residents of the fifty (50) United States and the District of Columbia (excluding Puerto Rico and U.S. territories) who, as of the date of entry, are 18 years of age or older. Employees of Sponsor and its respective affiliates, advertising and other coordinating agencies, and the immediate family members and/or household members of any such persons or entities are not eligible to participate in the Hunt. The Hunt is subject to all applicable federal, state and local laws and regulations and void where prohibited or restricted by law.

3. HOW TO ENTER: During the Hunt Period, read or download the list of Hunt questions. Enter answers to the Scavenger Hunt questions on the official entry form located at the Sponsor’s website (<http://www.craftyarncouncil.com/ilyd-contests>).

4. WINNER SELECTION: At the conclusion of the Hunt, Sponsor staff will randomly select 20 winners who have entered the correct answers to all of the Hunt questions and randomly award the assorted prizes.

5. WINNER NOTIFICATION: Prize winners will be notified by Sponsor via e-mail or other method specified on the registration form, as applicable and Sponsor’s discretion. Except where prohibited by law, prize winners may be required to sign and return an affidavit of eligibility and publicity/liability release within seven (7) days of notification and provide any additional information reasonably required by Sponsor. Sponsor shall not be liable for any prize notification that is lost, intercepted or not received by a winner for any reason.
